MEMBERSHIP INFORMATION

MEMBERSHIP EXTENSION PROGRAM

The Membership Extension Program extends a membership when a member attends more than one banquet in a year. An example of how this works is: A current member attends three membership banquets in the same year and pays membership dues with each ticket purchased. Their membership will be extended for three years.

As an added incentive, a member may upgrade their membership level to Life Member at any time and only pay the difference.

If a member has his/her membership extended to three years, the member may pay the difference of any accumulated time over the present year and receive a life membership. Any membership time under one year is not considered accumulated time.

LIFE MEMBERSHIP PAYMENT PLAN

An explanation of how the life membership payment plan works is outlined below.

New Member Payment Schedule

4 payments @ \$100.00 each

Payment Plan Coupon Book is sent. First payment due upon receipt of Coupon Book, each additional payment due at one month intervals. For Credit Card or Cash/Check Payments Only.

Or

8 payments @ \$50.00 each,

billed to credit card monthly for 8 months. For Credit Card Payments only.

Membership Card

When the final \$100.00 or \$50.00 payment is made, all Life Membership materials will be sent, including membership card and certificate.

Existing Member Transferring to a Life Member

Current members can have the dollar value of their remaining membership time beyond the present membership year deducted from the \$400 life membership fee. A member wishing to do this must contact the National Headquarters to verify

the amount to be deducted. That deductible amount will be valid until the end of the present membership year. After that date, the deductible amount is reduced by one year.

A current member will be credited for the accumulated value of their membership when the final life membership payment is made.

Example: If an existing membership's accumulated value is \$40.00, three \$100.00 payment must be made and the final payment to become a life member is \$60.00. Any membership time less than one year is not considered as accumulated value.

The process of receiving a membership card is the same for transferring members as it is for new members and is outlined above.

Payments are Non-Refundable

If you decide to stop making payments, the amount paid to date will be applied toward regular membership time.

Example: If \$100.00 is paid and a member discontinues the life membership payment plan that person will receive 5 years worth of regular membership time (based on a \$20.00 annual membership fee).

Attending Banquets While Enrolled in the Life Membership Payment Plan

If you are enrolled in the life membership plan and purchase a banquet ticket, you are required to pay the \$20.00 annual membership fee included in each ticket price. When the National Headquarters receives the banquet membership list from a chapter, your life membership payment plan will be credited \$20.00. This \$20.00 will be subtracted from your final payment.

Only after your life membership dues of \$400 are paid in full can you begin to deduct WTU membership dues from future banquet ticket prices.

Incentive Offers

Any incentives offered at the time you enroll in the life membership payment plan will be sent after your life membership dues of \$400.00 are paid in full.
